TRADER'S, AUTOJUMBLER & CRAFT SAFETY RULES

Please note that, whilst this Club makes every effort to ensure that the event is run in a safe manner, it is the responsibility of Traders, Autojumbler and Craft Exhibitors to abide by the Safety Rules (These rules form part of the contract between the Club and yourself. Anyone ignoring these rules may be asked to leave the site and will forfeit their entry fee.):-

1. Current and appropriate Public Liability Insurance of at least £2,000,000 must be held where necessary.
2. Current and appropriate Product Liability Insurance must be held where necessary.
3. All mechanical or electrical equipment displayed, for sale or in use at the event must be in a safe condition and, where appropriate, must be covered by a current safety certificate issued by a Competent Person.
4. Traders, Autojumbler and Craft exhibitors **must** comply with Stewards' and the Safety Officer's instructions throughout the event.
5. For safety reasons vehicles **must not** be moved on the rally site during the opening hours of the event except under the supervision of a Steward unless the exhibitor has the specific agreement of the Organisers. This will be strictly applied.
6. Admission to the site after 09.30 am will not be permitted on Rally days.
7. The event is advertised as being open from 09.30 am to 5.00 pm (Sat) & to 4.00 pm (Sun). All Traders and Exhibitors are expected to remain on the Showground during those hours. We will endeavour to get you off the site as quickly as possible after the event has finished – **PLEASE DO NOT LEAVE BEFOREHAND.**
