#### CONDITIONS OF ENTRY – Entries will only be accepted on the understanding that these will be complied with

- All entries shall be adequately covered by Public Liability Insurance to a minimum of £2,000,000 **and evidence may be requested.**
- Exhibitors **must** be in close attendance whenever the exhibit is in power or in motion.
- Exhibitors **must** comply with Stewards' and the Safety Officer's instructions throughout the event.
- Vehicles **must NOT** be moved on the rally site during the event except under the supervision of a Steward (this means all vehicles, not just exhibits).
- No exhibitor will be permitted to enter the site after 09.30am on Rally days.**
- All exhibits **must** be in position by **09.30am** each day. **(This will be strictly applied and includes cars and motorcycles).**
- Crawlers and Tractors on spade lugs must not be driven around the Rally site.
- ALL** drivers must hold a current and appropriate driving licence when driving their vehicle on the Rally site.
- All self-propelled** vehicles **must** be insured for **third party risks** as required by the Road Traffic Act when being driven on the Rally site and evidence must be provided when requested by a steward.
- No passengers may be carried on vehicles or trailers unless those vehicles and trailers are properly constructed, intended or adapted for such purpose.
- The event is advertised as being open from 09.30am to 5.00pm (Sat) and to 4.00pm (Sun). **All** exhibitors are expected to remain on the site during those hours. We will endeavor to get you off the site as quickly as possible at the end of the event as we realize that some of you have a long way to travel. **Owners of self-propelled vehicles are also requested to take part in the ring event for their section; it helps to create interest.**

## RULES FOR EXHIBITORS

Please note that, whilst this Club makes every effort to ensure that the event is run in a safe manner, it is the responsibility of Exhibitors to abide by the Safety Rules. Despite asking people to comply with these rules we had as many problems with uncontrolled movement of vehicles last year as in previous years and if we don't solve the problem the Council Public Protection Officer could stop us operating:-

1. All entries **must** be covered by Public Liability Insurance of at least £2,000,000.
2. Exhibitors **must** be in close attendance whenever the exhibit is in motion.
3. Exhibitors **must** comply with Stewards' and the Safety Officer's instructions throughout the event.
4. Vehicles **must NOT** be moved on the rally site during the opening hours of the event except under the supervision of a Steward unless the exhibitor has the specific agreement of the Organisers. (This will be strictly applied).
5. No exhibitor will be permitted to enter the site after 09.30 am on Rally days.
6. All exhibits must be in position by 09.30 am.
7. Crawlers and Tractors on spade lugs must not be driven around the Showground.
8. **ALL** drivers must hold a current and appropriate driving licence when driving their vehicle on the Showground.
9. All self-propelled vehicles **must** be insured for third party risks as required by the Road Traffic Act when being driven on the showground and evidence must be provided when requested by a steward. (This is in addition to the Insurance required under [1] above).
10. No passengers may be carried on vehicles or trailers unless those vehicles and trailers are properly constructed, intended or adapted for such purpose.
11. The event is advertised as being open from 09.30 am to 5.00 pm (Sat) & to 4.00 pm (Sun). **All** Exhibitors are expected to remain on the Showground during those hours. We will endeavour to get you off the site as quickly as possible after the event has finished - we know some of you have a long journey home.

**Those choosing not to comply with these Rules may be asked to leave the event without recompense.**
